This Management Report of Fund Performance represents the portfolio management team’s view of the significant factors and developments affecting the investment fund’s performance and outlook for the period ended June 30, 2025. In this report, “Manager”, refers to NewGen Asset Management Limited, the Manager of the Fund. The “Fund” refers to the NewGen Focused Alpha Fund. In addition, “net asset value” or “NAV” refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based. All dollar figures are reported in Canadian dollars or in thousands of Canadian dollars, unless otherwise indicated.

Investment Objective and Strategies

The Fund's principal investment objective is to provide investors with long-term capital gains. In order to achieve its investment objective, the Fund intends to invest in a concentrated portfolio of high-quality equities predominantly listed in Canada. The Fund may use leverage. The leverage will be created through the use of cash borrowings, short sales and derivative contracts. The aggregate gross exposure of the Fund shall not exceed the limits on the use of leverage permitted under applicable securities legislation.

The Fund primarily invests long, but it may also opportunistically short equities that offer the potential to generate outsized returns and to offset market risk. The Fund will hold a portfolio of approximately 25 core equity positions. Portfolio construction will rely on in-depth fundamental analysis with the aim of identifying attractive equity opportunities in the Canadian investment universe. It may also invest up to 20% of its NAV in securities of listed in the U.S. equities or in U.S. issuers when compelling risk-reward opportunities arise. Positions will be weighted in the portfolio relative to their estimated potential return as estimated by the Manager, as well as the securities’ underlying liquidity and risk profiles.

Risk

The risks associated with investing in the Fund remain as discussed in the Prospectus. The Fund is suitable for someone who is looking for steady long-term capital appreciation and a stable stream of income in a diversified portfolio of investments to hold as part of their balanced portfolio and has a medium to longer term investment horizon.

There were no significant changes to the investment objectives and strategies that affected the Fund's overall level of risk during the reporting period.

Terrorism, War, Natural Disaster and Epidemic Risk

Terrorism, war, military confrontations and related geopolitical events (and their aftermath) can lead to increased short-term market volatility and may have adverse long-term effects on U.S. and world economies and markets generally. Likewise, natural and environmental disasters, such as, for example, earthquakes, fires, floods, hurricanes, tsunamis and weather-related phenomena generally, as well as wide-spread disease and virus epidemics, can be highly disruptive to economies and markets into the medium term, adversely affecting individual companies, sectors, industries, markets, currencies, interest and inflation rates, credit ratings, investor sentiment, and other factors impacting the value of the Funds' investments.

Results of Operations

During the period ended June 30, 2025, Class C units returned 13.42%, Class F units returned 12.79%, Class G units returned 12.91 % and Class I units returned 16.65%, after fees. By comparison, the S&P/TSX Composite Index was up 10.17% on a total return basis. It is important to note that the Fund's return reflects the effect of fees and expenses for professional management, and it comprises both long and short positions, while the S&P/TSX Composite Index does not have such costs and is fully invested.

Class F USD has been offered for less than one year, the return for this Class is not provided. There was no trading for Class G USD during the period.

The net asset value (NAV) of the Fund increased by \$33.1 million to \$104.3 million from December 31, 2024 to June 30, 2025, with the main changes to equity derived through a combination of \$21.0 million in net inflows, \$nil million in distributions and \$12.0 million in net gain.

The first half of 2025 proved to be a tale of two quarters for North American markets, defined by sharp volatility, policy whiplash, and ultimately, resilience. After a strong start in January, equity markets were rattled by U.S.-led trade war in April. The highly anticipated "Liberation Day" announcement of sweeping tariffs triggered a violent sell-off, causing the S&P 500 to experience a peak-to-trough drawdown of 11.2%, including the worst single day drop in the market since 2020. However, weeks later, the market climbed back in response to a 90-day pause on tariffs, resulting in the S&P 500 experiencing its largest one-day gain since the 2008 GFC. By June markets, had recovered and advanced to new all-time highs as geopolitical tensions eased and the US Federal Reserve signaled a dovish pivot by year-end. Sector rotation defined market dynamics throughout the first half of the year. Technology and AI-linked names, particularly Nvidia, Microsoft, and Alphabet, drove Nasdaq strength, especially in the second quarter. Financials staged a late recovery as rate cut and deregulation expectations firmed. Geopolitical risk made a brief but sharp impact in June. Israeli airstrikes on Iranian nuclear sites sent oil prices spiking over 13% intramonth, with Brent crude briefly exceeding \$80/barrel, though fears of a wider regional conflict faded quickly. Gold surged 26% in the first half of the year, closing above \$3,400/oz in June, in response to higher policy and geopolitical uncertainty, alongside a weakening of the US dollar. Copper gained 8%, lifted by Chinese demand and speculative positioning tied to potential trade restrictions. Uranium climbed 12% year to date, as nuclear energy continues to be recognized as a cost effective abundant source of clean energy to power the expansion of AI. The price of Bitcoin made new highs in the year and continues to hold above \$100,000. Gains on the TSX were powered by materials (+29.2%), Consumer Discretionary (12.6%) and Financials (-8.7%), while Health Care (-7.3%) was the only sub-sector to finish in negative territory.

During the period ended June 30, 2025, the Fund did not breach the aggregate gross exposure limit of 300% of the Fund's NAV as prescribed by securities legislation, while the Fund's aggregate gross exposure ranged from 105.06% to 194.82% of the Fund's NAV during such period of time. As of June 30, 2025, the Fund's aggregate gross exposure was 105.70%. The primary source of leverage was short positions in equity securities.

Recent Developments

Macroeconomic data points towards a resilient economy with strong corporate earnings and a tight labour market. Expectation of Fed cuts later this year should provide for easier financial conditions, and have led market participants to indulge in greater risk-on sentiment. Sustained levels of AI related capex spending continues to inflect higher, meanwhile, inflation appears to be cooling. Conditions continue to appear supportive for equity markets, however, with major indices and their associated valuations at highs, investors are also mindful of a reappearance of policy uncertainty and renewed potential for geopolitical conflict. We continue to see opportunities within the Canadian market, given its large exposure to key commodities, along with its reasonable earnings yield and a valuation that comes at a steep discount compared to its US peers.

Related Party Transactions

Management fees:

As a result of providing investment and management services, the Manager receives a management fee calculated and accrued daily based on the NAV of the class of units of the Fund, plus applicable taxes, payable on the last day of each calendar month. For the period ended June 30, 2025, the Fund incurred management fees of \$353,541 plus applicable taxes. Management fees, if any, in respect of Class I units are direct fees negotiated with the investor.

The Manager uses these management fees to pay for sales and trailing commissions to registered dealers on the distribution of the Fund's shares, investment advice, as well as general administrative expenses relating to the Manager's role as Manager.

Performance fees:

The Manager receives a performance fee in respect of each class of units of the Fund. The Fund will pay the Manager a performance fee each calendar quarter (a "Performance Fee Determination Period") equal to 15% of the Net Profit (as defined below) of each applicable class of units subject to the High Watermark (as defined below). The performance fee will be calculated and accrued for each class on a daily basis during each Performance Fee Determination Period and, with respect to an intra-quarter redemption of units of a class, on the relevant redemption date. For the period ended June 30, 2025, the total performance fees incurred were \$2,326,030.

Net Profit means, in respect of any class of units of the Fund for any Valuation Day, the positive amount (if any) calculated by deducting the NAV per unit of the class for that Valuation Day from the highest NAV per unit in respect of which a performance fee liability has previously arisen (the "High Watermark") (or the initial offering price of the units if no performance fee liability has previously arisen in respect of such class of units). The performance fee will be determined by multiplying the amount of Net Profit by the total number of the units of such class outstanding at the close of business on such Valuation Day.

No performance fee shall be paid in respect of a class unless the class NAV per unit exceeds the High Watermark and, in such circumstances, a performance fee shall only be paid on that portion of the Net Profit that exceeds the High Watermark.

Investors in Class I units may negotiate a performance fee to be paid by the investor that is different than the one described above or no performance fee at all.

- (2) Net assets and distributions are based on the actual number of units outstanding at the relevant time. The increase/(decrease) from operations is based on the weighted average number of units outstanding over the financial period.
- (3) Distributions were paid in cash or automatically reinvested in additional units of the Fund, or both.
- (4) This information is provided as at June 30, 2025, December 31, of the years shown as applicable.
- (5) Management expense ratio is based on total expenses (excluding distributions, commissions and other portfolio transaction costs) for the stated year and is expressed as an annualized percentage of daily average NAV during the year.
- (6) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average NAV during the year.
- (7) The fund expense ratio represents total fund expenses expressed as an annualized percentage of daily average NAV during the period. It is the sum of the management expense ratio and the trading expense ratio, inclusive of performance fees and net of any fee waivers, rebates or absorptions. Prior-year fund expense ratios are not presented, as year-over-year comparisons are not mandated under total cost reporting requirements.
- (8) The Fund's portfolio turnover rate indicates how actively the Fund's advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the units in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in the period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

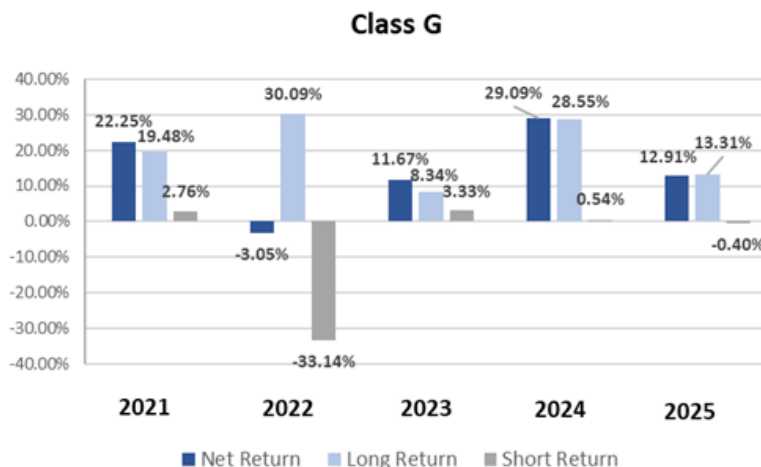
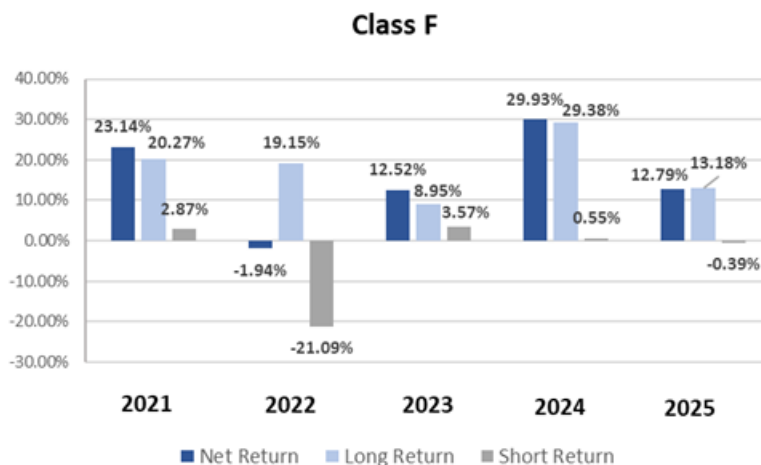
Past performance of the Fund

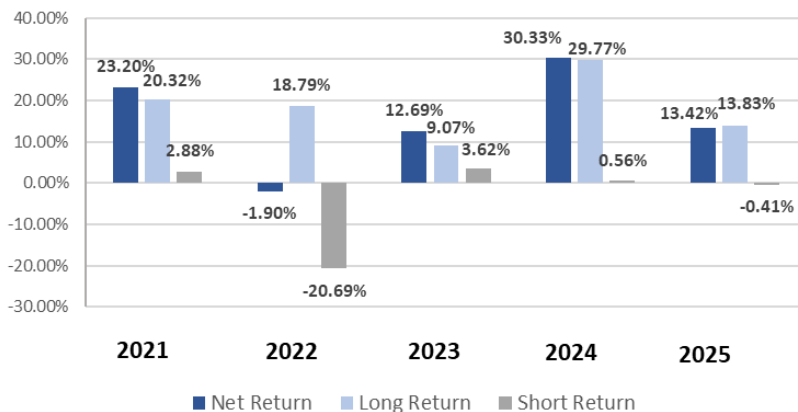

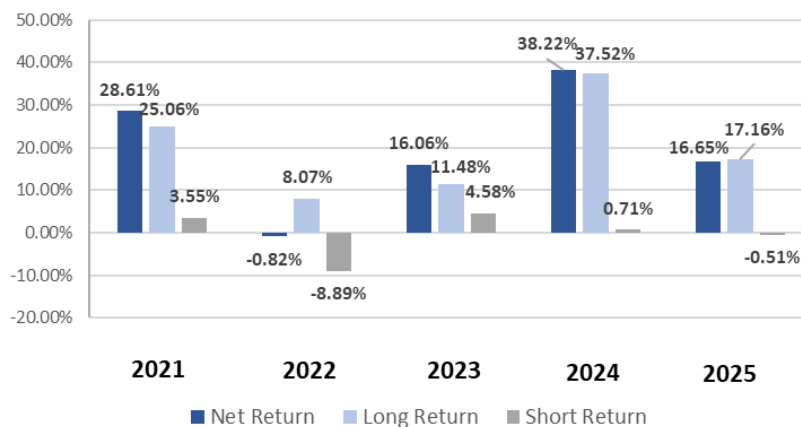

Summary of Investment Portfolio

Portfolio Composition
